ORGANIZING STUDENTS TO END MASS CRIMINALIZATION AND INCARCERATION ROOM 311-312

For Students - Facilitated by Students Against Mass Incarceration

Students Against Mass Incarceration's workshop will address strategies and challenges in organizing students to end mass criminalization and incarceration on college campuses. Starting with the importance of reconciling our many contradictions as students, attendees will consider questions like: what are students of color's stake in organizing for prison abolition? What is at stake in this work considering the privileges we hold as students? How can we stay organized, and balance our responsibilities as activists and students? Using the Columbia Prison Divest campaign as an example, SAMI will discuss how to develop strategies that reflect the group's politics, and that stay true to a larger abolitionist vision. Other objectives for the workshop include discussing the creation and maintenance of organizational structures, internal relationships and solidarity with student groups, other university campuses, and off-campus organizations.

FROM CRIMINAL JUSTICE TO HUMAN JUSTICE: ORGANIZING STRATEGIES FOR SHIFTING PARADIGM AND PRACTICE ROOM C05

For people who are Formerly Incarcerated, Their Family Members and Those Organizing in Impacted Communities - Facilitated by Kyung-Ji Rhee, Divine Pryor and Chino Hardin from the Center for NuLeadership on Urban Solutions

This workshop will be geared towards directly impacted community members, specifically formerly incarcerated youth and adults, and their family members, and community organizers who work with these communities. This workshop will introduce and explore the formula for and application of Human Justice – as the merger between Human Rights and Human Development – as developed and practiced by the Center for NuLeadership on Urban Solutions.

Workshop leaders will share their experiences of faith-based organizing in the North Carolina Moral Monday Forward Together Movement, Beloved Community Center initiatives, and the newly organized “Hub” at Union Theological Seminary. Be prepared for open dialogue and ways to get involved in actions and strategic planning that is happening in NYC right now.

ABOLISH THE BOX: ORGANIZING TO CHALLENGE THE ROLE OF HIGHER EDUCATION IN PERPETUATING MASS INCARCERATION ROOM 404

Open to All - Facilitated by the Incarceration to Education Coalition

Mass incarceration affects our institutions: from housing and employment to education. For the past year, the Incarceration to Education Coalition has been organizing to Abolish THE BOX on college applications: most higher education institutions in U.S. demand applicants disclose their criminal records. This discriminatory process must be abolished. Join IEC organizers in an interactive workshop where we will discuss possibilities for practicing abolition in the context of institutional oppression. Can we build a future without punishment and oppression? Can we reimagine accountability?

ORGANIZING AGAINST EMPIRE: REALITIES OF THE PEOPLE’S RESISTANCE ROOM C03

Open to all - Facilitated by Tongo Eisen-Martin

In this workshop we will analyze state domestic military violence and incarceration against oppressed people in the United States. Every bullet, every bar, benefits a larger picture. We will deconstruct that larger picture, and from our analysis, we will determine organizing practices for contemporary work for liberation.

FARMS NOT PRISONS: USING FOOD JUSTICE TO CHANGE THE CRIMINAL PUNISHMENT SYSTEM ROOM C05

Open to all - Facilitated by Jalal Sabur and the Freedom Food Alliance

Participants will learn how to make the connections between food, farming and the prison industrial complex. Presenters will explain how an alliance of farmers, organizers and political prisoners created a model that addresses Food Access, Prison Reform/Abolition, Restorative and Transformative Justice, Transportation, Environmental Justice and Economic Justice. This will be an interactive workshop with a small powerpoint presentation on how our Freedom Food Alliance, our Vehicle Cooperative, and our Victory Bus Project are bringing families in urban areas of New York to prisons in rural areas of New York for a box of fruit, vegetables and dairy from farms in the Hudson Valley. We will also have a strategy session on how participants can bring this model back to their local areas and build a national movement to have more farms and less prisons.
